UNITED NATIONS GENERAL ASSEMBLY (UNGA) - DISEC

AGENDA:

Impact of the recent peace talks on enhancing the compliance and regulatory mechanism for private military and security companies with special focus on the ongoing Russo - Ukrainian conflict and global security.

The shadow of private military and security companies (PMSCs) looms larger than ever over today's battlefields. As Ukraine debates legalizing its own PMCs to enhance defense efficiency, Russia has moved to centralize control over its mercenary forces, with notorious groups like Wagner playing pivotal roles in the protracted battles of Bakhmut and beyond. Recent Russian efforts to consolidate and regulate PMCs reflect a broader global trend: governments are increasingly seeking to both leverage and constrain these private actors, recognizing their ability to adapt quickly and innovate in conflict zones.

Meanwhile, Ukraine's arms industry has undergone a dramatic transformation. Private firms now account for over half of state defense contracts, driving modernization and resilience amid relentless attacks and shifting foreign aid dynamics. These developments highlight the urgent need for robust international compliance and regulatory frameworks-especially as both sides in the Russo-Ukrainian conflict rely more heavily on non-state military actors.

Recent peace talks have generated momentum for global action. Ukraine's draft legislation on PMCs-backed by the Ministry of Defense but facing calls for tighter oversight-aims to harness private initiative for national defense while minimizing the risk of abuse. At the same time, international scrutiny has intensified: the UK's designation of the Wagner Group as a terrorist organization and ongoing debates over transparency in the arms industry underscore the high stakes for global security.

Delegates at the Assembly of Nations 2025 will confront these evolving realities head-on, tasked with developing innovative solutions to regulate PMSCs, prevent war crimes, and ensure accountability in an era where the lines between state and private warfare are increasingly blurred.

The situation in the Middle East:

Special focus on escalation of hostilities in the Israel- Palestine conflict

The Israel-Palestine conflict has reached a catastrophic juncture. Since October 2023, over 52,000 Palestinians have been killed and 118,000 injured in Gaza, with women and children accounting for 70% of the casualties. Following the collapse of the March 2025 ceasefire, Israel reinstated a severe blockade -cutting off access to food, water, and humanitarian aid-pushing 2.1 million people to the brink of starvation and disease.

UN experts have warned that the deliberate deprivation of essential resources and widespread destruction of infrastructure may constitute acts of genocide. They are urging the international community to move beyond rhetoric and take enforceable action to end the carnage and hold perpetrators accountable. In a historic move, the International Criminal Court has issued arrest warrants for leaders of both Israel and Hamas, citing alleged war crimes and crimes against humanity-signaling a new era of international legal scrutiny. Humanitarian organizations are facing

unprecedented challenges. Aid convoys have been blocked or targeted, critical infrastructure lies in ruins, and more than 660,000 children are out of school, enduring malnutrition, trauma, and disease. The United Nations Security Council's agenda is shaped by these grim realities and by urgent appeals from UN agencies and human rights groups.

Delegates must confront the immediate need for a ceasefire, the establishment of humanitarian corridors, and mechanisms for accountability. At the same time, they must grapple with long-term questions of reconstruction, justice, and the viability of a two-state solution. The Assembly of Nations 2025 offers a crucial platform for decisive diplomatic action-echoing the world's call to end the suffering and forge a just path forward for all affected communities.

UNITED NATIONS COUNTER-TERRORISM COMMITTEE (UNCTC)

"Technology is the new battleground where geopolitics and security converge."

AGENDA:

Combating the Use of Emerging Technologies by Terrorist Organizations

The accelerating convergence of technology and geopolitics has redrawn the frontlines of counter-terrorism. Terrorist organizations are rapidly leveraging artificial intelligence, blockchain, drones, and encrypted platforms to recruit, radicalize, and finance operations across borders with unprecedented speed and stealth. In response, the UN Security Council's Counter-Terrorism Committee (CTC) adopted new guiding principles in 2025, focusing on the prevention, detection, and disruption of terrorist exploitation of emerging technologies-particularly virtual assets and Al-driven threats.

International efforts now include coordinated policy dialogues, such as the December 2024 Rome Summit on Al and terrorism, along with joint initiatives with the OSCE aimed at strengthening legislative frameworks and enhancing digital literacy-especially among youth, who are increasingly targeted by online extremist propaganda.

Recent developments underscore the urgency of global action: the CTC's multi-stakeholder approach has brought together over 120 parliamentarians and 80 experts to harmonize strategies, while the expansion of the OSCE's parliamentary coordination mechanism from 9 to 17 assemblies marks a new era of collective vigilance. Educational campaigns and policy reforms are being prioritized to build societal resilience, combat online disinformation, and foster responsible innovation-without compromising human rights.

The UNCTC session at the Assembly of Nations 2025 stands as a dynamic forum where delegates must craft forward-looking solutions to confront the rapidly evolving nexus of technology and terrorism-striking a balance between security imperatives and digital freedoms.

CONFERENCE DETAILS

- 1. The conference will be held on the 3rd and 4th of July, 2025 at our Main Campus, located at 72, S.N. Banerjee Road, Maula Ali, Kolkata 700014.
- 2. Each delegation must consist of a minimum of 5 and a maximum of 9 delegates.
- 3. Delegates must be students of Grades IX to XII in the 2025-2026 academic year.
- 4. A second delegation may only be registered if the first delegation comprises 9 delegates. No inter-delegation swaps will be permitted after registration.
- 5. The dress code for both days of the conference is the school uniform.
- 6. The Conference Handbook, including the Rules of Procedure, Conference Schedule, and other details, will be made available on the conference website closer to the event. Further the Study Guides and other relevant committee documents for the benefit of the delegates will be uploaded to the conference website by 20th June 2025.
- 7. Committee sessions will run from 8:00 a.m. to 4:00 p.m. All accompanying faculty members are expected to remain with their respective delegations throughout this period.
- 8. All delegates must attend the opening ceremony, committee sessions, and closing ceremony in school uniform and must wear their school identity cards at all times.
- 9. Access to the internet might be restricted according to the committee regulations.
- 10. Participants must adhere to general disciplinary rules, and any violations may result in disqualification from the conference."

- 12. All participating schools are requested to send their confirmation emails, delegation lists, and payment confirmations at the earliest to ensure a smooth registration process.

REGISTRATION DETAILS
